'THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage or cost they may incur due to the presence of the undersigned in upon or about the STUDIO premises or in any way observing or using any facilities or equipment of the STUDIO whether caused by negligence of the releasees or otherwise.
